BOWERS MANSION BLUEGRASS FESTIVAL SATURDAY AUGUST 20, 2022**

This Agreement is entered into between _____ (print your name/business name) and the Northern Nevada Bluegrass Association/Bowers Mansion Bluegrass Festival Committee for the Bowers Mansion Bluegrass Festival scheduled for Saturday, August 20, 2022 from 8:30am to 6 pm at the Bowers Mansion Regional Park in Washoe Valley, NV. Booths or Food Vans may be set up on Saturday morning beginning at 7:00 am and should be complete enough by the time the bands begin playing at 9:15 AM so as not to create a distraction. No booth may be torn down or food van removed prior to close of festival. Overnight camping is not allowed at the park but is available at nearby Davis Creek Park. No electricity will be available to the booths or food vans. Generators are allowed but must be non-intrusive and the exhaust must be directional away from the festival area. Vendors must provide their own canopy, booth equipment, tables, chairs etc. Vendors are responsible for clean-up and tear-down of their space at the end of the Festival.

- (1.) **FEES: \$65.00 per 10'x10' space or per food vendor space.** (The fee includes 2 festival tickets). Additional festival tickets available online at www.bowersbluegrassfestival.org or may be purchased the morning of the event.
- (2.) SALES TAX: Vendors are required to pay all applicable State of Nevada Sales Tax.
- (3.) VENDOR shall be limited to selling the merchandise or food described below. No controversial, sexually implicit merchandise or weapons allowed. Merchandise is subject to approval of Festival Coordinator.

- (4.) VENDOR is responsible for keeping area clean and free of debris during and after the festival.
 - (5.) VENDOR COORDINATOR will assign booth space on a first come-first served basis.
 - (6.) NORTHERN NEVADA BLUEGRASS ASSOCIATION/BOWERS MANSION BLUEGRASS FESTIVAL COMMITTEE is not responsible for property of or injury to any customers or personnel associated with your booth or merchandise.
 - (7.) NO BOOTH SPACE WILL BE RESERVED WITHOUT PRIOR PAYMENT OF FEES AND COMPLETED SIGNED APPLICATION.
